

TaxWorkFlow License Terms and Conditions

Thank you for downloading TaxWorkFlow, a computer software program and accompanying documentation for tax accountant professionals ("TaxWorkFlow"). These terms and conditions ("Terms") govern your access and use of TaxWorkFlow and constitute a legal agreement between you ("Licensee" or "You") and the owner of TaxWorkFlow, TaxWorkFlow, LLC ("Licensor"). TaxWorkFlow is proprietary to Licensor and Licensor is only willing to provide TaxWorkFlow to you on the condition that you accept all of these Terms. By installing TaxWorkFlow you agree to be bound by these Terms and these Terms become effective ("Effective Date"). If you are unwilling to accept these Terms, do not install TaxWorkFlow.

1. **DEFINITIONS**

1.1 "Confidential Information" means any and all technical and non-technical information provided by Licensor to you including, without limitation, Licensor's information concerning research, experimental work, development, design details and specifications of TaxWorkFlow; the Feedback; the development status of TaxWorkFlow;

the functionality of TaxWorkFlow; the appearance, content and flow of TaxWorkFlow's screens; the method and pattern of user interaction with TaxWorkFlow; and the Documentation.

1.2 "Documentation" means the documentation provided by Licensor to Licensee in connection with TaxWorkFlow.

2. LICENSE.

- 2.1 Grant. Subject to these Terms and the payment of the License Fees set forth in Section 3 below, Licensor grants Licensee a nonexclusive, nontransferable license to install, display, and execute TaxWorkFlow solely for Licensee's professional use. This license shall terminate immediately upon expiration or earlier termination of these Terms as set forth in Section 7. All rights not specifically granted to Licensee herein are retained by Licensor.
- 2.2 Restrictions on Use. Except as otherwise specifically permitted under these Terms, Licensee shall not use, copy, modify, create derivative works of, distribute, sell, assign, pledge, sublicense, lease, loan, rent, timeshare, deliver or otherwise transfer TaxWorkFlow, nor permit any third party to do any of the foregoing. Licensee may not:
- (a) derive or attempt to derive the source code of all or any portion of TaxWorkFlow by any means,
- (b) permit any third party to derive or attempt to derive such source code, or
- (c) reverse engineer, decompile, disassemble, or translate TaxWorkFlow or any part thereof.

3. LICENSE FEES.

3.1 Licensee shall pay an annual license fee after the expiration of the trial period ("Payment Date") and on each anniversary date of such Payment Date.

4. OWNERSHIP.

- 4.1 TaxWorkFlow. Licensee agrees that Licensor will own and hold all right, title and interest, including but not limited to copyright, patent, trade secret, and all other intellectual and industrial property rights, in and to TaxWorkFlow, any Documentation and any changes, modifications or corrections thereto.
- 4.2 Assignment. If Licensee is ever held or deemed to hold any right, title or interest (including, without limitation, any intellectual property rights or trade secret rights) in or to TaxWorkFlow or Documentation (including any changes, modifications or corrections thereto), then Licensee hereby irrevocably assigns to Licensor all such right, title and interest and agrees to execute all documents necessary to implement and confirm the letter and intent of this Section. Licensee will cooperate with Licensor and will take all actions, including the execution, verification and delivery of documents, as Licensor may reasonably request to evidence, perfect or protect Licensor's rights in and to TaxWorkFlow and any Documentation.

5. PRIVACY

- 5.1 Licensee is responsible for safeguarding the password used to access TaxWorkFlow and agrees not to disclose its password to any third party. Licensee is solely responsible for any third party using TaxWorkFlow through Licensee's installation of TaxWorkFlow, whether or not Licensee authorized such activity. Licensee acknowledges that if it wishes to protect its transmission of data or files to TaxWorkFlow, it is Licensee's responsibility to use a secure encrypted connection to communicate with TaxWorkFlow.
- 5.2 By using TaxWorkFlow, Licensee consents to the collection, transfer, processing, storage, disclosure and other uses of Licensee's information by Licensor described in these Terms. All of the different forms of data, content, and information described below are collectively referred to as "Information." Licensor may collect and store the following Information when Licensee is running and using TaxWorkFlow:
- (a) <u>Licensee Information.</u> When Licensee installs and uses TaxWorkFlow, Licensor collects some personal information, such as name, phone number, email address and home and business postal addresses of Licensee.

- (b) <u>Files.</u> Licensor collects and stores the files uploaded to TaxWorkFlow by Licensee on Licensor's server.
- (c) <u>Log Data/Cookies</u>. When Licensee uses TaxWorkFlow, Licensor may record information from Licensee's computer systems, such as Licensee's Internet Protocol address, browser type and identification numbers associated with Licensee's computer systems, date and time stamps associated with transactions and metadata concerning Licensee's Files. Licensor may use "cookies" to collect information and improve TaxWorkFlow, in order to save Licensee's registration ID and login information or to better understand how users interact with TaxWorkFlow.
- 5.3 Personal Information. In the course of using TaxWorkFlow, Licensor may collect personal information that can be used to contact or identify Licensee ("Information"). Information is or may be used: (i) to provide and improve TaxWorkFlow, (ii) to administer your use of TaxWorkFlow, (iii) to better understand Licensee's needs and interests, and (iv) to provide or offer software updates and product announcements.
- 5.4 Data Retention and Confidentiality. Licensor will retain Licensee's Information for as long as these Terms are in effect. Licensor may retain and use Licensee's Information as necessary to comply with its legal obligations, resolve disputes, and enforce these Terms. Licensor will delete Licensee's Information quickly upon request or upon termination of these Terms. However, Licensee acknowledges that there might be latency in deleting information from Licensor's servers and backed-up versions might exist after deletion. Licensor follows generally accepted standards to protect the Information submitted by Licensee and keep such Information confidential, both during transmission and once it is received and stored. No method of electronic transmission or storage is 100% secure, however. Licensor cannot guarantee its absolute security. In case of security breach or other security events Licensor will notify Licensee about it not later than within 2 working days.

6. ACKNOWLEDGMENT.

6.1 Licensee understands and acknowledges that all data and information stored in TaxWorkFlow (such as customer information and documents) may be deleted by Licensor upon termination of these Terms pursuant to Section 7. There may be an option for Licensee to download this data to continue using it in-house, but Licensor does not give any promises or guaranties that these options will be available upon termination of these Terms. Licensee acknowledges that it may forever lose such data upon termination of these Terms.

7. TERM AND TERMINATION.

- 7.1 Term. These Terms, unless terminated earlier as set forth herein, shall be effective from and after the Effective Date until the day that is one year after the Payment Date and shall automatically renew for successive one year periods.
- 7.2 Termination by Licensor. Licensor may terminate these Terms immediately upon written notice to Licensee in the event Licensee materially breaches any provision hereof. In addition, Licensor may terminate this Agreement for any reason or no reason at all upon thirty (30) days written notice to Licensee. Upon such termination, Licensor shall refund all license fees paid pro rata for the unexpired term of the license from the date on which such termination became effective.
- 7.3 Termination by Licensee. Licensee may terminate these Terms upon fifteen (15) days written notice to Licensor. Upon such termination, Licensor shall refund all license fees paid pro rata for all periods beginning with the month immediately following the effective date of such termination.
- 7.4 Return of TaxWorkFlow. Upon expiration or earlier termination of these Terms for any reason, Licensee agrees to delete all copies of TaxWorkFlow from all of Licensee's computer systems and, at Licensor's option either: (i) return to Licensor all copies and partial copies of TaxWorkFlow in Licensee's possession or under Licensee's control that are stored on tangible media, or (ii) destroy all such copies and partial copies and certify such destruction to Licensor in writing.

7.5 Survival. Any provision in these Terms that should naturally extend beyond the termination, expiration or other ending of these Terms shall survive termination, expiration or other ending of these Terms.

8. WARRANTIES/LIMITATION OF LIABILITIES

- 8.1 NO WARRANTY. TAXWORKFLOW, DOCUMENTATION, AND ANY AND ALL OTHER MATERIAL PROVIDED BY LICENSOR TO LICENSEE UNDER THESE TERMS ARE PROVIDED TO LICENSEE "AS IS" WITHOUT WARRANTY OF ANY KIND. LICENSOR HEREBY DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY WITH RESPECT TO TAXWORKFLOW, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT, TITLE OR FITNESS FOR A PARTICULAR USE OR PURPOSE. LICENSOR DOES NOT WARRANT THAT TAXWORKFLOW WILL FUNCTION WITHOUT INTERRUPTION OR THAT IT IS ERROR-FREE. LICENSEE BEARS THE ENTIRE RISK AS TO THE OPERATION OF TAXWORKFLOW.
- 8.2 LIMITATION OF LIABILITY. IN NO EVENT WILL LICENSOR BE LIABLE FOR ANY DAMAGES, INCLUDING WITHOUT LIMITATION LOSS OF PROFITS OR DATA OR THE COST OF SUBSTITUTE GOODS, WHETHER IN CONTRACT OR TORT (INCLUDING NEGLIGENCE), INCLUDING DIRECT, CONSEQUENTIAL, SPECIAL, EXEMPLARY, INCIDENTAL AND INDIRECT DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THESE TERMS, OR LICENSEE'S USE OF, OR THE RESULTS OBTAINED FROM, TAXWORKFLOW, DOCUMENTATION, OR ANY OTHER MATERIAL PROVIDED BY LICENSOR TO LICENSEE UNDER THESE TERMS. Licensee acknowledges and agrees that the disclaimer of warranties, limitations on liability and limited remedies contained in these Terms are fundamental parts of the basis of Licensor's bargain hereunder, and Licensor would not be able to provide TaxWorkFlow to Licensee absent such limitations.

9. CONFIDENTIAL INFORMATION.

9.1 Use and Nondisclosure. Licensee will hold the Confidential Information in strict confidence, and use such care and take all precautions to protect such Confidential

Information as Licensee employs with respect to its most confidential materials, but in no case less than reasonable precautions. Licensee may not use or reproduce the Confidential Information for any purpose except as specifically permitted under these Terms. Licensee may not disclose any of the Confidential Information or any information derived therefrom to third parties, other than to Licensee's employees who have a need to know and are subject to an obligation of confidentiality.

- 9.2 Exclusions. The term Confidential Information does not include, and the obligation of confidentiality hereunder will no longer attach to, information when Licensee can document that such information: (a) was already in Licensee's possession, free of any obligation of confidence, as shown by Licensee's written records in existence at the time of disclosure; (b) is or becomes generally known to the public at the time Licensor communicates such information to Licensee, or subsequently, through no breach of these Terms by Licensee; (c) is received independently and without restriction by Licensee from a third party not under an obligation to Licensor or others to keep such information confidential; (d) is independently developed by Licensee's personnel without the benefit of access, directly or indirectly, to Confidential Information of Licensor; provided, however, that Licensee will bear the burden of proving that such personnel did not benefit from access to the Confidential Information.
- 9.3 Ownership and Return of Confidential Information. All Confidential Information and materials furnished to Licensee by Licensor will remain the property of Licensor. Upon termination or expiration of these Terms, or upon written request of Licensor, Licensee shall promptly return to Licensor all documents and other tangible materials representing Licensor's Confidential Information and all copies thereof.
- 9.4 Mandatory Disclosure. The restrictions of Section 7 will not operate to prevent disclosures of Confidential Information required by any law or regulation, or in response to a valid order by a court of competent jurisdiction or other governmental authority; provided, however, that Licensee provides Licensor with prompt written notice of such pending disclosure and makes a reasonable effort to obtain, or to assist Licensor in obtaining, a protective order preventing or limiting the disclosure.

10. GENERAL PROVISIONS

- 10.1 Injunctive Relief. Licensee acknowledges that its breach of Sections 5 or 9 will cause irreparable harm to Licensor for which monetary relief would be insufficient, and hereby agrees that Licensor will be entitled to injunctive relief as well as such further relief as may be granted by a court of competent jurisdiction in the event of breach or threatened breach of Sections 5 or 9, without the posting of a bond or other security.
- 10.2 Governing Law. The validity, performance, construction and effect of these Terms shall be governed by the laws of the State of New York, U.S.A., excluding its choice-of-law rules.
- 10.3 The parties hereby waive any and all rights to demand a trial by jury in any action, suit or proceeding arising out of or relating to these Terms or the transactions contemplated by these Terms.
- 10.4 Assignment. These Terms bind and benefits the respective successors and assignees of the parties. However, Licensee may not assign or delegate any of its rights or obligations under these Terms without the prior consent of Licensor. Any purported assignment or delegation in violation of these Terms shall be void.
- 10.5 Modifications. Licensor may revise these Terms from time to time. If a revision, in Licensor's sole discretion, is material, Licensor will notify Licensee. By continuing to access or use TaxWorkFlow after revisions become effective, Licensee agrees to be bound by the revised Terms. If Licensee does not agree to the new terms, Licensee shall immediately stop using TaxWorkFlow and this Agreement terminates effective immediately.
- 10.6 If any provision of these Terms will be held invalid or unenforceable by a court of competent jurisdiction, the remaining provisions of these Terms will remain in full force and effect, and the provision or portion thereof affected will be construed so as to be enforceable to the maximum extent permissible by law.
- 10.7 Waiver. All waivers must be in writing. Any waiver of either party to enforce a provision of these Terms on one occasion will not be deemed a waiver of any other provision or such provision on any other occasion.

10.8 Complete Agreement. These Terms are the complete and exclusive statement regarding the subject matter hereof and supersede all prior agreements, understandings and communications, oral or written, between the parties regarding the subject matter hereof.
